tio MOS-3074/5238 -51 -- In exercise of the towers conferred by the proposition to article 309 of the Constitution of India, the Covernor of Maharashtra needy makes the following rules to amend the Maharashtra Development Service (Constitution, Classification and Recountment.) Rules, 1973, namely :---

RULES

- (a) These rules may be called the Maharashtra Development Service (Constitution). Classification, and Recruitment) (Amendment) Rules, 1974.
 - (b) They shall and shall always be deemed to have come into force on and from the 15 th day of August, 1973.
- In rule 4 of the Maharashtra Development Service (Constitution Classification and Reconstruct). Prices, 1973 (hereinafter referred to as "the said rules") in sub-rule (1) for clause (a) the following shall be substituted framely.

* (a) by promotion of officers who have completed not less than ten years of continuous service in posts included in the Maharashtra Development Service, Charast, or any other posts which, in the opinion of the State Government specified at an order, involve duties comparable in importance and responsibilities to that of the posts in that Service, or

3. In rule 5 of the said rules ---

(i) for clause (a), the following shall be substituted, namely :--

"(a) by promotion of officers who have completed not less than seven years (including the period of probation) of continuous service in posts included in the Maharashtra Development Service, Class II, or any other posts which, in the opinion of the State Government specified in an order, involve duties comparable in importance and responsibilities to that of the posts in that Service, or";

(II) in the proviso, the words, brackets and letters " and has to his credit a continuous service of not less than seven years (including the period of probation)

in the Maharashtra Development Service, Class II," shall be deleted.
