Village Panchayats -Measures to avoid delay in finalisation of proposals regarding -

CIRCUIAR:- Sub-section(1) of section 4 of the Bombay Village Panchayats Act, 1958 empowers Government to establish Village Panchayats. Sub-section(2) thereof enables Government to alter the limits of existing Village Panchayats. The powers of Government under the abovesaid provisions have been delegated to the Commissioners of Divisions. Whenever it is proposed to declare any local area to be a "Village" under section 4(1) (that is establishing a Village Panchayat), the Chief Executive Officer of the Zilla Parishad has to make an inquiry as prescribed in the Bombay Village Panchayats (Declaration of Village)Enquiry Rules, 1959 to ascertain the population, the ordinary land revenue and the extent of such local area. The aim of Government is to cover the entire rural area by Village Panchayats. This has already been achieved as almost all such area is covered by either independent Village Panchayats or Group Village Panchayats. There is, however, a constant demand for establishment of separate Village Panchayats by splitting up the existing group Village Panchayats. At present, the norms laid down by Government to consider such demands are as follows:—

- (i) The new Village Panchayat proposed to be established should have a population of 600 or more. Exceptional cases (e.g. long distance between the existing units) or the cases of tandas, hamlets, wadis or local areas having less than 600 population but more than 250 may be considered for separate Village Panchayats.
- (ii) The proposed new Village Panchayat must be financially viable.
- 2. It is a common complaint that establishment of separate Vi]lage Panchayats by splitting up existing Village Panchayats takes quite a Fong time. According to the existing procedure, the work relating to formulation of proposals for splitting up of Group Village Panchayats and establishment of separate Village Panchayats is being done by the Chief Executive Officers. These officers are required to collect information regarding (i)population, (ii)land revenue and (iii)financial viability of the proposed Village Panchayats and to compile the said information in the forms 'A' and 'B' appended to the Bombay Village Panchayats (Declaration of Village)Enquiry Rules, 1959. They are also

required to consult the concerned Village Panchayats and the Standing Committee and submit the proposal to the Commissioner for further action. The question of streamlining the procedure with a view to minimising delays in this regard was under the consideration of Government for some time past. Government has come to the conclusion that the existing procedure is quite simple and convenient and needs to be continued. However, to speed up matters, the following steps should be taken :-

- (i) With a view to seeing that proposals are not held up for lack of information on vital points, they should be formulated and checked at each level with reference to the *accompanying proforma.
- In addition, registers in suitable forms should be maintained at Block level and by the Administrative officers at the Zilla Parishad level and they should be checked every month.
- (iii) The proposals are many times unnecessarily held up at the village level and the Zilla Parishad level (Standing Committee) for passing of resolutions by the concerned Village Panchayats and the Standing Committee of the Zilla Parishad. Government considered that it should not take more than 2 months to obtain such resolutions. The Village Panchayat may be given 2 months time to express its views and to pass the necessary resolution. It should be informed that if it fails to express its views within this time limit, it will be assumed that it has no objection to the proposal. The other information regarding survey numbers, population, income, land revenue, etc. should also be collected by the Block staff within this period of 2 months only. The Standing Committee of the 7:1112 of 2 months only. The Standing Committee of the Zilla Parishad must also express its views within a period of 2 months and if it fails to do so within this period, it may be told that it will be assumed that it has also no objection to the proposal.
- The officers concerned are requested to observe the above instructions very scrupulously so that the proposals for establishing separate Village Panchayats will not be delayed at any level and will be finalised early.
