RESOLUTION : Under Government Resolution, Public Health Department, No. PHC.1083/3656/PH-16B, dated the 2nd February 1984, establishment of 834 Primary Health Centres (764 in Non-Tribal areas and 70 in Tribal Sub Plan areas) was sanctioned. The establishment of these Primary Health Centres was stayed under Telegram, No. DHS/PDE/PHC/83-84/D-7, dated the 30th May 1984, from the Director of Health Services, Bombay. Government is, now, pleased to direct that the stay given for the establishment of these Primary Health Centres should be vacated except in respect of the 89 Primary Health Centres as indicated in Statement 'X' appended herewith. The orders regarding establishment of the 89 Primary Health Centres in the Statement 'X' will be issued in due course of time.

2. It is also noticed that some of the entries in the Statements 'B' & 'C' accompanying the Government Resolution, Public Health Department, No. PHC/1083/3656/PH-16B, dated the 2nd February 1984, are not clear and there are some typographical errors. The entries in those statements should therefore, be revised as indicated in Statement 'Y' appended herewith.

3. Government is pleased to direct further that the vehicles to be purchased for the Primary Health Centres, will be purchased and allotted by the Director of Health Services, Bombay, in a centralised manner. Though the stay for establishment of the Primary Health Centres has been vacated, no posts other than M.M. & H.S. Class-II Medical Officers sanctioned newly or by upgradation should be filled in without obtaining approval of or specific instructions from the Director of Health Services, Bombay.

4. The Director of Health Services, Bombay, will place appropriate grants at the disposal of the Zilla Parishads, for the establishment of 745 Primary Health Centres in respect of which the stay has been vacated.

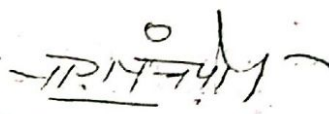
