In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Senior Draftsman, Class III in the Directorate of Groundwater Surveys and Development Agency under the Rural Development and water Conservation Department of the Government of Maharashtra, namely:-

- 1. These rules may be called the Senior Draftsman, Class III, in the Directorate of Groundwater Surveys and Development Agency (Recruitment) Relas, 1994.
 - 2. In these rules, unless the context requires otherwise,
 - (a) "Directorate" means the Directorate of Groundwater Surveys and Development Agency, Maharashtra State;
 - (b) "Government" means the Government of Maharashtra. (3,43)

- 3. Appointment to the post of Senior Draftsman in the Directorate shall be made either,--
 - (a) by promotion of a suitable person on the basis of seniority subject to fitness from amongst the persons holding the post of Draftsman in the Directorate for a period of not less than three years as a regular service; or
 - (b) by nomination from amon ist the candidates who,—
 - (i) unless already in the service of Government are not more than thirty years of age; and
 - (ii) possess a degree of a Statutory University in Civil, Mechanical or Electrical Engineering ; of
 - (iii) possess a Diploma of an Institution recognised by Government in Civil Engineering with at least three years practical experience in Draftsman-ship.
 - Appointment by promotion and nomination shall be in the ratio of 75:25:

Provided that, if in the opinion of Government, the exigencies of service so required, Government may, after consultation with the selection authority, wherever necessary make appointment to the post in relexation of the percentage prescribed under then Rule, for recruitment by promotion or nomination.

- 5. A person appointed to the rost shall be liable to be transferred any where in the State of Mahereshtra.
- 6. A person appointed to the post shall be required to pass the Departmental Examination and Examinations in Hindi and Marathi, according to the rules made in that behalf, unless he has already passed—or has been exempted from passing those examinations.
